



Reference to your application submitted to RRB/SC for the post of ALP/Technician and consequent upon your selection to the said post vide Chairman/RRB/SC's letter No. RRB/SC/607/1-155/CEN 01-2018 dt.20.01.2020 cited (under reference), you are hereby offered appointment to the post of 'Trainee Artisan' in Welding trade in level - 02 of VII CPC Pay Matrix with the stipendiary pay of ₹.19,900/- p.m. plus dearness allowance as admissible under rules in force from time to time, subject to following conditions.

The above appointment is subject to the following:

01. You have to be found fit in the prescribed medical classification by an Authorized Medical Officer. If you fail in the medical examination, you will not be appointed.
02. You shall produce all original certificates in proof of age, educational qualification and caste certificate etc. issued by prescribed authority including a copy of the PAN card issued in your favour and details of bank account along with one set of Photostat copies.
03. You should execute a bond (₹.10/- special adhesive stamp shall be affixed) of agreement to serve Railways for a period of 05 years after completion of training. Copy of agreement is enclosed. This agreement must be attested by your parent or guardian, duly witnessed by 2 Government employees.
04. You will be under training normally for a period of six months and if there is any adverse report during the period of training, your training is liable to be terminated. Your absorption as Technician Gr.III will be subject to successful completion of the prescribed training.
05. On completion of training, you will have to serve the Railway Administration for a minimum period of five years, if required by the Administration. You will not be allowed to withdraw from Training, except for any reasons which are beyond your control. In case you fail to serve the administration for a minimum period of five years as stated above, or desire to withdraw from training for any reasons which are not beyond your control or try to withdraw by willfully absentsing yourself or adopting any other unfair tactic, you will be liable to refund the whole cost of your training as well as any other money paid to you during the period of Training by way of stipend/pay etc. The cost of training is 12 ½% of stipendiary pay and allowances drawn.

As a result of successfully qualifying written examination conducted by the Staff Selection Commission and completion of the recruitment process you have been allotted for enlistment in CRPF. Accordingly you are provisionally selected for appointment as Constable (General Duty) in CRPF. The post is purely temporary but likely to continue.

2. The Pay Scale of Constable (General Duty) as per 7th CPC lies in the pay matrix-3 and is Rs. 21,700/- as on date. In addition to this, you will be entitled to Dearness Allowance, Ration Money, Washing Allowance and other allowances as entitled to the Central Govt. employees from time to time and other allowances/benefits as admissible to the CRPF personnel.

3. The terms and conditions of appointment are as under:-

- The post is contractual and purely temporary but likely to continue. On appointment to the said post, you will be on probation for a period of two years. On successful completion of the period of probation, you will be considered for confirmation. Your services are liable to be terminated at any time by the appointing authority without assigning any reasons, on one month's notice during the initial period of 02 years in accordance with the Central Civil Services (Temporary Service) Rules 1965.
- The appointee carries with it the liability to serve anywhere in India or outside of India.
- On joining this organization you will be governed under CRPF Act-1949 read with CRPF Rules-1955 and other recruitment rules notified / amended from time to time.
